 - 7.1.1 Construction phase project updates including completion of the installation of Phase 1 underground utility infrastructure, tie in at public utilities ongoing.
 - 7.1.2 Building 100 update: steel framing complete, wall framing ongoing.
 - 7.1.3 Building 900 update: grade beams complete, foundation work beginning
 - 7.1.4 AMS building update: Construction of modular buildings in the factory is complete. Foundations for buildings 500, 600, 700 and 800 are complete, foundation for building 400 is in progress. Buildings 600 and 700 have been transported to site and placed on foundations.
 - 7.1.5 Overview of schedule provided, anticipated Phase 1 substantial completion early February.
 - 7.1.6 Overall Bond Expenditures Series A and B complete and funds adjusted to zero out those phases. Interest to date updated as well as future interest anticipated. Negative balance of Series B (\$8,949.12) transferred from Series C. Deficit in Series C will be funded by the District's special reserve for capital projects and other funding sources.
